Mr. Matheson updated the Committee on the Del Valle Complex Renovation Project. He reported that interior demolition has been going on for approximately ten days and will continue for another two weeks. There have been no major surprises yet, and getting the modulars up and running has been challenging due to a variety of issues. There will be City inspections on Thursday, April 13th, and Friday, April 14th. Providing the modulars pass the inspections, the temporary fitness facilities are scheduled to reopen in the modulars on Monday, April 17th.
