- a) Lawn Maintenance: Turf is being mowed every 3-4 weeks due to slow winter growth and saturated soils. Irrigation is now OFF.
- b) Entry Maintenance: Crews are focusing drain and v-ditch clearing and will turn to rejuvenation pruning when the weather calms.
- c) Tree Maintenance: A tree walk will be scheduled for next week.
- d) Landscape Rehab: MOD days occur in May and October this year, the landscape manager will schedule a walk with the landscape representative in the month prior to identify projects to undertake.
